#### **New Feature**

- \*\*Admin > Manage Users > User Details Current Permissions & Leave > Leave
   Calendar: Added a Leave Calendar "View Only" permission to allow users to view the Leave
   Calendar without any other access to the Leave Module. APTAWEB-12055
- AptaFund Timekeeping API: The suffix appends to the employee's last name field.
   APTAWEB-12260
- **My AptaFund > My Information -** Added AptaTime PIN to this screen APTAWEB-12319
- \*SSO (Single Sign On) AptaFund is introducing a Single Sign On (SSO) method of authentication, which will allow users who login via a third-party identity provider to log in to AptaFund using their own network accounts. Those users would not need to login to AptaFund separately. This method will also support multi-factor authentication, if that is what the user's existing Identity Provider supports. Please verify with your Information Technology Department, and if you are interested in configuring AptaFund SSO, please contact AptaFund Client Support.

- \*\*My AptaFund > Employee Self-Service > My Deductions: Added employee signature to the W-4. A "Sign" button was added to the bottom of the W-4 document (Federal and State). The signature is uploaded along with the current date. If no signature exists, it will display the employee's legal name in printed form along with the current date. APTAWEB-12047
- \*\*Human Resources > Employee Contracts
  - Added "Employee Signature" to bookmarks in Employee Contracts to allow signature(s) on documents. Added a "Sign" button to the My AptaFund > My Documents Grid for signing documents requiring a signature. APTAWEB-12148
  - Removed "Preview" button and renamed "Publish to ESS" button to "Preview/Publish to ESS". APTAWEB-12065
- \*Human Resources > Employee Jobs > Mass Update: The Add Designation feature will
  now be allowed for Closed and Approved jobs as well as New. APTAWEB-12195







# Improvements (cont'd)

- \*Leave:
  - Prevent employees from creating a leave request for a negative amount. Users will get a message that the leave request cannot be for an amount less than zero.

  - Added a leave rollover cap schedule to the Leave Types. Rollover caps can now be scheduled like accruals based on years of service. – APTAWEB-11088, APTAWEB 11954 & APTAWEB-11525
- **Payroll > Deduction Assignment:** Added state of Washington to the State dropdown in Deduction Details popup. APTAWEB-12210

### **Bugs Fixed**

- **Accounts Payable > Vendor Invoice:** Ordering Vendor filtering issue corrected when filtering names such as 'Andrew' or 'Anderson' any word that contained 'and'. This includes all grid filtering throughout AptaFund 4.1. APTAWEB-12125
- \*Leave > Leave Details Add Leave Request:
  - Fixed the issue of not showing the total hours per day when multiple primary jobs exist for employee. APTAWEB-11800
  - An error message now will display if no approval process is assigned to the leave type. This was also changed in My Leave Requests and Manage Employees.

- \*My AptaFund > Reports Maine Quarterly Unemployment Contributions and Wages Report: Corrected to now show Gross Wages reduced by Pre-Social Security deductions. APTAWEB-12245
- Payroll
  - \*Manage Deductions Deduction Rollover: Fixed the issue where some deduction fields were not set correctly in the new fiscal year after rolling over the deduction. Those fields are 'Is 125 Deduction', 'HSA Support', 'Display on W-2' and 'Allocate To'. APTAWEB-9148
  - Manage Payroll Payroll Register: Fixed the issue causing incorrect detail pay for allocated hourly and OT hourly jobs. This was due to the same account being used, AptaFund now handles this situation. APTAWEB-11931
- Purchasing > Admin Purchase Requisitions: E-commerce transfer XML error has been corrected. APTAWEB-12144
- \*State Specific > NPERS Report: The Nebraska PERS Report will include Leave and Holiday hours from the payroll register in the total hours for employees whose jobs are marked as NPERS Reportable. APTAWEB-12134
